



## 2018 Pioneer Farmsteads, LLC Produce Purchaser Agreement



The following are the agreements between: Pioneer Farmsteads, LLC (hereinafter, the Farm) and \_\_\_\_\_ (hereinafter, Purchaser).

1. The Farm will provide, unprocessed, organically grown produce to the Purchaser once a week for 16 weeks from approximately June 1, 2018 until approximately September 30, 2018.

2. The Purchaser or his/her agent is responsible for picking up the harvested produce at 7000 Garrison St, Arvada CO 80004, weekly between 5pm and 7pm.

Circle one: **Wednesday** or **Thursday** produce pickup. *This will be your pickup day for the entire season.*

3. Any share that is not picked up by the designated times (unless we are notified otherwise) will be donated to a charity of the Farm's choice or a designated needy family. (See item 7 below)

4. This agreement acknowledges (choose one):

\_\_\_\_\_ the payment by Purchaser of \$350 for a produce share (feeds 2 ).

\$75 due at signing, remaining balance due before April 1, 2018.

\_\_\_\_\_ the payment by Purchaser of \$600 for a double produce share (feeds 4 ).

\$100 due at signing, remaining balance due before April 1, 2018.

Sales tax of 3.96%  
=(0.50% Jefferson  
County and 3.46%  
Arvada) is included in  
the purchase price of all  
shares and deposits.

5. Based upon the season and the contingencies of farming (e.g. extreme temperatures, hail, wildlife damage, pests, drought, etc.) it is possible that the number of harvests and/or the produce share sizes may not meet the anticipated harvest goals of the managers of the Farm. Purchaser agrees to bear the risk of variable harvests or crop failures due to unfavorable conditions that are beyond the control of the managers of the farm.

6. Purchaser understands that the content of the produce share is unprocessed and unwashed and that Purchaser is responsible for the adequate cleaning and preparation of said content in order to render it fit for human consumption. Purchaser agrees to bear all risk of any illness acquired by Purchaser or other people consuming the content of the Purchaser's produce share that results from consumption of any portion of produce share content. Purchaser also understands that customizing the content of produce shares to Purchasers' individual preferences is not possible.

7. The Purchaser may designate another person to receive their produce for any of the weeks covered by this agreement. The Purchaser will notify the Farm of the designated person so we know who is authorized to pick up produce.

8. The purchaser has the option to cancel this contract for a refund of the full amount of a produce share less the non-refundable deposit agreed upon in item 4 prior to April 1, 2018.
